Development Outreach Team



Well another busy three months and the opportunity to meet as many members as possible at the Forums and through meetings and visits have been fantastic.

Help To Live At Home

As mentioned in the last newsletter a group of members have, for nearly the last two years, Help to Live at Home project. This group has

been involved with Wiltshire Council's Help to Live at Home project. This group has now become known as the Customer Reference Group (CRG).

The CRG has now had training from Wiltshire Council. They have also had a meeting with three of the four companies who have been awarded the contracts to provide domiciliary care.

Part of the Help to Live at Home project includes contracts for providing equipment and 'telecare' packages for people as well as providing a first response service. The equipment contract has been awarded to Medequip who in turn have sub contracted the 'telecare' part of the contract to Aster Living. "Telecare is the term used for equipment that can be installed into a person's home to provide an alert or alarm system. It can include things like lifeline pendants, smoke alarms, fall alarms, heat sensors and many more. If the alarm should be set off, it goes to a call centre who will provide a response to the customer. This response service contract has been awarded to Wiltshire Medical Services (WMS). So in the event of a person's alarm



being set off WMS will receive the call and make a decision on whether to send a paramedic, another service or one of their first responder teams. The CRG had a very useful presentation on the uses of 'telecare' packages and many members of the group have visited Wiltshire Medical Services to see how they will operate the first response service.

The main purpose of the CRG will be to monitor how all these providers meet the needs of all those people who use their services. They will do this by speaking to those who have care packages or use telecare packages to find out if there are any issues or indeed if the service is meeting their needs and expectations. The findings that the CRG makes will be referred to both the Care Provider and Wiltshire Council. As the CRG is an independent and impartial group it is hoped that customers of the providers will feel able to speak freely to them and give a true picture of the service they receive.

Older People

We helped at the Older People's event in both Corsham and Salisbury where the Slipper Exchange proved very popular and we were able to introduce ourselves and sign up several members. We also attended the Older People's Forum planning meeting in Swindon and as you will see from David Brown's article we would like to hear from our members who would like to join and receive more information about the future development and work of the Swindon Older People's Forum. Copies of the constitution can be requested and WSUN's Development Outreach Team will be helping to facilitate the four meetings planned throughout the year, also offering to visit members who may not be able to attend the meeting to gather feedback and ideas to support Older People's service provision.

Stonehenge Consultation

In the winter 2011 newsletter there was an update on the English Heritage Consultation for the new visitor centre for Stonehenge. In December, as reported a group of members who have been involved with the Stonehenge Visitor Centre Consultations met to discuss



the accessibility and suitability of a transport system designed to take visitors from the visitor centre to the stones.

This transport system a form of 'land train' was discussed in some detail. A lot of questions were raised about how wheelchair users and others with mobility problems would access the carriages of the 'land train'. It was felt, at the end of this session, that members of the group had raised a lot of points that needed to be 'tested' before the design of the proposed land train was passed to the manufacturers.



A second meeting was held at the beginning of February and Peter Carson and Martin Harvey from English Heritage came to meet members of the group and produced a life size plan of a carriage, marked out on the floor of the meeting room. Group members could actually see if it was possible for wheelchair users and those with mobility problems to easily get into the carriage. It was a most interesting session and did, as expected, raise

even more questions for English Heritage and the designers to look into.

I believe that all the members of the group who took part felt that it was a really positive exercise and I know that English Heritage were very pleased with the input the members were able to make. English Heritage have agreed to keep us updated on the project.

Acute Care Forum

We continue to attend the Acute Care Forum on a monthly basis at Green Lane Hospital. The Acute Care Forum is a group that meets monthly to explore performance and service development at both Green Lane Hospital in Devizes and Fountain Way Hospital in Salisbury. Feedback is given to the Acute Care Forum where particular issues arise that may affect the care pathway of an individual.

Care Pathways ensure equal access to services across Wiltshire. Feedback is also given from the Community Mental Health Teams, Occupational Health Team and Psychological Therapies. There is representation from the inpatient Carers Representatives and Ward staff. Any complaints and areas of good practice are reviewed and updates on the Acute Care Services Redesign is given.

Community Campuses

WSUN has recently supported the work of Melksham, Royal Wootten Bassett and Calne Shadow Community Operations Boards. The Boards are charged with developing community campuses that bring together and increase local services to meet the needs of its local community area. Services may be different in each area offering leisure, internet cafe, personal care rooms, training rooms, meeting spaces, council officer 'hot desks' etc. so it is the work of the Boards to make sure the campuses are welcoming and accessible.

We were very pleased to be able to invite members to Equality and Inclusion workshops to share their expertise and knowledge. In addition to how the campuses could be accessible to include disabled people, the Boards were asked to consider programming of activities, opening hours, communication (languages, plain English, symbols, different formats etc.), different cultures, all ages, staff training and travelling to /from the campuses. All the contributions and further questions were sent to Wiltshire Council who have subsequently responded. Mental Health

Members who use mental health services in Wiltshire continue to meet 4 times a year. The groups are small, informal and welcoming. They provide members with a chance to keep up to date with changes that may affect them and raise concerns. These meetings are a great way of shaping services as concerns are taken forward by Denise and Samiha (Service User Reps) to manager's meetings. Recent guest speakers have included Peter Hollingworth (Intensive Support Service Manger) who provided an update regarding the AWP Redesign and Sarah MacLennan (NHS Communications Manager) who spoke about the changes in the NHS and the introduction of Clinical Commissioning. The next Our Time To Talk (OTTT) meeting will focus on Alabaré Include - members will have a chance to talk to managers from Wiltshire Council and Alabaré. Denise and Samiha would like to hear views on Alabaré's use of 'Christian Care and Support' and use of the fish symbol on promotional material. If you have views to share, please contact the development outreach team to pass on to the reps before Thursday 29th March. WSUN knows that it is not always possible for people to attend meetings so if you would like to be involved in another way please let us know.

New Developments

WSUN has been working towards increasing involvement of younger people who use community, health and/or social services. A very exciting multi-media arts project is currently being planned. Working with a local established arts group, WSUN hopes to attract a small group of 8-10 young people who are able to meet with the art group on a regular basis for up to 10 weeks. 5

During this time, they will have the opportunity to meet new people, develop skills and confidence and create a DVD for us to use to highlight any barriers that get in the way of independence and lifestyle. If you are or know anyone who is 18-25 years who has a learning difficulty or disability (sensory/physical), please encourage them to contact us.

Other visits have been made to a range of Care Homes, Supported Accommodation and other organisations including: the New Supported Accommodation Scheme in Trowbridge, the Gables Registered Care Home in Chippenham and the new Mind Support Service at the Gifford's surgery in Melksham.

We also attended the Carer's Rights Day in Swindon, an update of the National Carers Strategy was discussed and also the potential to support more local agencies to develop their ongoing work.

As with all our visits we continue to offer the chance to meet Service Users to share information and help with giving feedback to Commissioners, and agencies that can help with individual issues, or ongoing review and the planning of future Service Provision.

Information Feature UP AND RUNNING!! SWINDON OLDER PEOPLE'S FORUM (SOPF) Contributed by Dave Brown, Chair.

Perhaps not running as such but certainly moving along at a fair pace, is the newly formed Swindon Older People's Forum (SOPF). So what will the Forum aim to do and how will it make a difference? Older People's Forums exist throughout the UK and all operate slightly differently but at the heart of their existence is the desire to be fiercely independent of outside influences whilst seeking to promote the welfare and interests of older people. When they are effective they help this age sector to have a louder voice on matters which impact on their everyday lives by capturing, and helping to resolve, their issues and concerns.

Swindon Older People's Forum has already made it clear that it will ensure that it does not overlap with, or antagonise, the activities of existing groups, clubs and organisations across the Borough. However from April 2012 the "One Swindon" vision will see major changes in the way that service providers (local authority; emergency services; NHS etc.) will interact with, and engage with individuals and organisations. SOPF's development over the next few months needs to reflect these changes and will therefore focus on:

- Continuing to raise awareness of its existence amongst the service providers
- Widening membership and participation
- Exploring partnership opportunities with organisations who have like minded interests.

Regardless of the general enthusiasm and support for an Older People's Forum here in Swindon, the impending changes locally provide an even greater need to ensure that the voice of older people is included and heard.

We attended a Community Consultation Event hosted by Swindon

Borough Council (SBC). The consultation included adult services within the community and how SBC can work together with other organisations to work smarter, more effectively and within their budgets. Organisations from different areas of the community were invited to give their views and comments, all the information would then be considered before they finalise the changes.

Fairer Charging Event - Swindon Borough Council - Throughout January several drop in sessions, covering all of the Swindon area, were organised by Swindon Borough Council about the proposals of the new fairer charging policy. In Swindon they want to make sure that the new charging policy is fair and asked for input from as many people as possible who use these services. There will be some interesting changes taking place which should be fairer for everyone from extra care services to disabled parking badges. Swindon Forums

We will be holding two Swindon forums in the Spring. One on **Monday 26th March** at **Ellendune Community Centre, Wroughton**, and the other on **Tuesday 17th April** at **Meadowcroft Community Rooms, Stratton** both from **10.30am-2.30pm.** Guest speakers will attend to give presentations about Adult Social Care and the Great Western Hospital. These events will be very informative regarding the future of Swindon health and social care and we would be delighted if you can join us.

There are some changes taking place for **The Wheelchair Focus Group.** At present, we do not have as many service users attending the group as we would have hoped. At the last meeting in January it was proposed that the group expand its remit to cover all social care services, therefore anybody who has difficulties with mobility and their carer's and relatives will be welcome. To reflect this, we have renamed the group '**The Swindon Mobility Club'.** The new format will be in the style of a coffee morning which will include specific topics for discussion to be decided by the service users.

We will continue to hold meetings on a monthly basis at Clapham Hobbs with the next meeting taking place on **Thursday 1st March from 10.30am-12.30pm.** Please feel free to drop by and have a coffee and a chat.

Personal Independence Payment (PIP) update

WSUN has told the PIP (Policy Section) to make an Easy Read or a PIP (Policy Section) to make an Easy Read or a PIP (Policy Section) to make an Easy Read or a PIP (Policy Section) to make an Easy Read format most likely because much of the content is still being talked about in Government.

On 16 January 2012, the PIP Team published more detail on the second draft of the Personal Independent Payment assessment criteria. The PIP Team are seeking further views from disabled people and their organisations to ensure that they get the assessment criteria right. The consultation will run for 15 weeks, from 16 January to 30 April 2012. You can view this consultation by visiting the DWP website http://www.dwp.gov.uk/consultations/2012/pip.shtml where you will find more information.

The final draft assessment regulations will be laid before Parliament later this year, subject to Royal Assent of the Bill, and will be subject to Parliamentary scrutiny through the 'affirmative procedure'. This means that to become law they must be approved by both the House of Commons and the House of Lords. You can use this information to put together your own individual response. However, WSUN will be replying to the PIP "Assessment Thresholds and Consultation". If you would like to support us in giving your views on these concerns, could we please ask you get your comments back to us, **by no later than Tuesday, 10th April 2012,** so that we will have a chance to collate your comments, in time to meet the **PIP Team deadline, of Monday, 30th April 2012.**

Wiltshire Council is looking for people to use their skills and champion the benefits of getting online.

The Wiltshire Online team is launching a new volunteering initiative in the Melksham area to help more people to get online and confident in using the internet.

This scheme is part of the council's four year programme to roll out superfast broadband to a minimum of 85 percent and up to 95 percent of premises across the county. The volunteering project will see 'digital champions' help people learn the skills they need to get online and benefit from faster, more reliable broadband.

Wiltshire Online is now working with the Volunteer Centre Wiltshire to recruit a number of digital champions in the Melksham area. These volunteers will help with a pilot project due to start in the Melksham area later this month before the scheme is rolled out across the county.

Digital champion volunteers can give as much or as little of their time as they want at a time and a place that is convenient to them.

The team is also looking for a local volunteer coordinator to help support the network of digital champions in the Melksham area.
